Re: Continuity Report: 2013-14 *What is the Price of Dysfunction? The San Mateo County Harbor District – Response 1*

Honorable Continuity Committee:

The 2013-14 Civil Grand Jury report on the Harbor District included Recommendation No. 1: **The Local Agency Formation Commission will initiate a service review of the Harbor District by December 31, 2014.**

San Mateo LAFCo responded that the recommendation would be implemented. At the November 19, 2014 Commission hearing, the Commission authorized release of a request for proposals for preparation of a municipal service review and sphere of influence update (MSR/SOI Update) for the Harbor District. On January 21, 2015, the Commission authorized a contract with Economic Planning Systems to prepare the MSR/SOI Update. Harbor District staff have been very cooperative in providing necessary information to the consultant. The LAFCo Executive Officer is regularly attending Harbor District meetings to stay abreast of District budget adoption, recruitment and other activities.

It is now anticipated that the Circulation Draft MSR/SOI Update Report will be available in mid-May. LAFCo staff will hold a community workshop after release of the circulation draft. Once comments are received a final report will be presented to the Commission at the July 15 meeting, unless an earlier special meeting is scheduled.
