Nice to hear from you. We will need the following to proceed with the EIR Addendum for the increased grading for Lots 5-8:

1. Based on Cotton Shires and Associates' (County's Geo consultant; CSA) recommendations, the County will need an updated letter and update of 2015 report to current building code for Lots 5-8
2. New Section 1 form for Lots 5-8.
3. Signed Section II when Lots 9-11 are finalled (pending)
4. For Lots 9-11, as-built plans are required per Geo-2b (I added to the Geo Final inspections).

Please see full conditions and mitigation measures pertaining to this project attached.

FYI, as the project lost its Project Geotechnical Engineer due to COVID, the County's consultant (CSA) answered project geo comments/questions received from the public during the comment period for the grading modification. Please let me know if you need to see the original comments.
