I conducted my site inspection at Highland Estates this morning. Overall the site looks better, and I can see that they made an effort to clean up the stucco. I would like to see additional clean up following the removal of the scaffolding, and the repair/replacement of most of the silt fence along the south side of Lot 11 so that it is functioning as intended prior to any earthwork or rain events. I requested that Bob repair the existing silt fence onsite for now while they are preparing for the painting crew, and have limited access to the site with the scaffolding in the way.
